“Finally Justice Will Be Done”

On November 15, 1982, De Anna Lynn Johnson (age 14) had innocently attended a neighborhood party just a few doors away from her residence. The next morning her body was found next to train tracks; she had been brutally beaten to death. For well over three (3) decades, her senseless death remained a mystery until an arrest was made this past January. Marvin Markle, Jr. (already in prison for a previous murder conviction) has been charged with the murder of De Anna Lynn Johnson. “We miss her very much,” said De Anna’s mother, Ginger Dimpel. “And we are encouraged that the truth will prevail, and finally justice will be done.” Citizens Against Homicide became involved with De Anna’s case; facilitating a Reward Billboard featuring the Governor’s Reward Proclamation of \$50,000. To De Anna, her family and friends, you are in our hearts and thoughts... and we continue to pray for swift justice.

A Few Words From Jan

Here we are well into the third month of 2017 and I am just now sitting down to write a few words and thoughts for our next newsletter. Let me assure everyone, the lack of a Newsletter is not due to lack of energy, nor a lack of newsworthy articles to put into the Newsletter. Rather it is not enough hours in our day.

So, using my usual MO of asking forgiveness rather than permission, let me start by sharing with you some of the good things that have occurred thus far in 2017.

We learned of an arrest in the case of De Anna Lynn Johnson, age 14, who was murdered on November 15, 1982 in the downtown square on Elmira Road in Vacaville. CAH has been involved with this case for many years, which included a reward billboard and numerous interactions with police, family and friends of De Anna.

Another cold case near and dear to all of our hearts has been solved. This case was especially of concern to Shellie and Gene Cervantes. Larry Powers, their neighbor

and friend, went missing in 2007, while on a trip to Arizona. In late January, his body was recovered and an arrest has been made for his murder. The murderer happens to be his best friend! Truly a time of extreme emotion for the family and friends of Larry.

One of CAH's priorities for 2017 was to gain much more exposure for cold cases. We will be putting up several reward billboards in two cases within the immediate future. Those cases are Veronica Perotti, murdered in Chico, June 28, 1984 and Michele Kirkhoven, murdered in Oroville, January 3, 1991. Both of these cases are from Butte County in California.

Sometimes as we walk through life, there are certain individuals who touch our lives in a way much different than most. I have written many a note about wonderful people in my life and have shared many an adventure of my children and grandchildren. Today, I would like to share a very inspirational story with you. This story is about my cousin, David "Rock"

Holloway. I remember as if it was yesterday the day I learned he had a diving accident and, as a result, was paralyzed from the neck down. Yet every time we met, he had a positive thought and fun stories to share. In the last month of 2016, while attending his memorial service, I was so moved by the words of his sister that I immediately felt the need to share with all of you.

David “Rock” Holloway was born on November 28, 1949 in San Francisco, CA to James and Alma Holloway. As a child, his family moved to Idaho, and then to Washington where he had a diving accident at the age of 16, leaving him paralyzed from the neck down. The family then moved back to the bay area for Rock to receive better medical treatment and physical therapy. Although Rock was physically limited, he never allowed his paralysis to stop him from moving forward. He earned his GED with the help of a tutor, and then enrolled at West Valley College. After earning his AA at West Valley College, he transferred to San Jose State, majoring in Finance. Rock graduated from SJSU in 1984 and was hired in 1987 at the Department of the U.S. Navy in the Program Management Office for Flight Systems. He served in a key

position as a Financial Management Analyst for the Trident II D5 missile system and fleet ballistic missile system. In 2009 Rock retired after 22 years of service.


In Rock’s spare time he loved to cook and try new recipes, cheer on the San Francisco 49ers, have a lively debate, go out to lunch, and spend time with his family. He was everyone’s cheerleader, a light for his family and friends and will be missed by many.

Reading this again today brings tears to my eyes. He was one of the most positive people I have ever known. So I ask each of you... think about your own hardship and then think of Rock. If we can do this, I guarantee we will find new strength from within and, perhaps, be able to reach greater levels of involvement to help those who need our help today.


Larry is Coming Home

Some of you may recall the story about our neighbor and friend, Larry Powers, who became a “missing person” case almost ten (10) years ago. (Larry was our featured Victim Profile in the July 2009 CAH Newsletter). It was not uncommon for Larry to head south (Arizona) on mining excavation trips with his good friend, Anthony Richards. However, when his home sat idle for an uncomfortable period of time, we all knew in our hearts something was wrong.

Throughout the years, we remained positive, never wanting to give in to doubt or give up hope. However, as the years continued to pass, our hopes began to wane; we knew he was gone and we knew he had to be somewhere out there in the Arizona desert. But where? And how could Larry’s remains ever be recovered after almost 10 years exposure to desert elements? Despite the discouraging odds, Larry’s sister, Joan, remained vigilant in her quest to find him and bring him home once and for all.

It would take a miracle. It would take a dedicated and caring Detective Paul Chastain. Because of Detective Chastain’s diligence in conducting a thorough investigation and an unwavering commitment to solve this case, suddenly new and solid evidence surfaced. The rest of the story is history (and wonderfully highlighted in the following excerpts from The Daily Courier (Prescott, AZ).



Lastly, it is a terribly heart wrenching experience when your worst thoughts turn to fruition. But, there is solace in knowing Larry is no longer a statistic “Missing Person” case and his murderer, Anthony Richards, will face harsh Arizona justice. But most importantly, Larry is coming home~

Larry, you are forever in our hearts.

PRESCOTT—Yavapai County Sheriff’s detectives have long believed that Larry J. Powers, who went missing in 2007, was a victim of murder. They even had a suspect. But they didn’t have the body, which makes prosecuting a murder case much more difficult.

After developing information that Powers, then 58, would most likely have been killed and buried in the area of a remote mining claim he was working near Bagdad, YCSO detectives flew a drone over the area last year and spotted a depression in the soil.

A preliminary excavation exposed a camp chair and other supplies, so plans were made to go back and do a forensic dig for evidence. “This subsequent

excavation yielded human remains believed to belong to victim Larry Powers,” YCSO spokesman Dwight D’Evelyn said.

Investigators believe Anthony Richards, who was with Powers on April 9, 2007, when Powers was last seen, is a suspect in the murder. The two men were partners in the Big Nugget mining claim near Bagdad.

Richards had made purchases on Powers’ credit cards that “directly benefited” him after Powers’ disappearance, D’Evelyn said.

A long investigation of Richards resulted in a 23-count indictment that accused him of trafficking in stolen property, theft of a handgun, theft of a credit card, and 19 counts of identity theft, all with victim Larry Powers, who had been declared dead by a California court in 2012.

Richards was arrested in Oregon, and, in May 2016, was brought back to Yavapai County.

The discovery of Powers’ body “is expected to lead to homicide charges against Richards and some sense of closure for the victim’s family,” D’Evelyn said.

Richards is still in custody on a \$100,000 bond after his May arrest, D’Evelyn added.

Dear Chairman and Parole Board Member:

Please DO NOT grant a parole date to convicted murderer, Francisco Eric Rubio, CDC# T-89385.

This convicted killer agreed to a plea agreement to obtain a lesser sentence and is guilty of a murder. He brutally bludgeoned and tortured Lora Ann Sinner, age 18, in early 1998 (the specific date of which the family has never known). She suffered excruciating pain for a very long and inhumane duration before being killed, dragged and buried in a shallow grave.

It is a crime and a terrible lack of justice that this convicted killer is entitled to a parole hearing at all. Convicted killers who strike plea agreements should have to serve out the full sentence handed down. Per the United States Supreme Court decision, "State prisoners have no constitutional right to parole". Because of his complete disregard for human life, sense of entitlement, and heinous nature of this crime, this convicted murderer poses a great risk to society and does not deserve the right to freedom.

Although commitment offense is now rarely considered by the Board during parole hearings, it is hoped you will think about this murderer's victim, Lora Ann Sinner, and take into consideration Rubio's unconscionable act of violence.

Please help Lora Sinner's family and friends from being victimized again by keeping her murderer behind bars where he belongs. Deny parole to convicted murderer, Francisco Eric Rubio, for the maximum time allowed by State of California law.

Dear Parole Board Chairman and Board Member,

It has come to my attention that the murderer of Frank Carlson is once again being considered for parole at a hearing scheduled for April 25, 2017.

The heinous nature of the nature of the crimes perpetrated by Angelo Pavageau should ensure that under no circumstances he be allowed to re-enter civil society.

The surviving victim of his unspeakable acts, Mrs. Annette Carlson lives in fear for her life should he be released. The Carlson family and their supporters have fought on an ongoing basis for the last 43 years for this criminal be retained in custody over the remainder of his natural life. His original sentence mandated death plus 54 years; it is only due to the technicalities of the legal system that he finds himself being considered for parole on a semi-regular basis since 1980. Forcing the Carlson family, their friends and supporters to relive the events of April 18–19, 1974, in the interest of the California legal system is cruel beyond words.

Angelo Pavageau's personal choice to brutally execute Frank Carlson and his personal choice to stalk, brutally torture and attempt to set afire Mrs. Carlson cannot be ignored by the Board. Because of Pavageau's complete disregard for human life and the unconscionable brutality of this crime for financial gain, justice demands this convicted murderer be denied parole.

In order to protect civil society from the impact this inmate could have, please deny parole to convicted murderer, Angelo Pavageau for the maximum time allowed by State of California law.
